The Foundation: Co-founded in **2003** by Peter Thiel with seed money from **In-Q-Tel** (the CIA's venture arm).

Strategic Surveillance

Palantir Gotham and Palantir Foundry synthesize DMV records, social media, and financial data into actionable profiles.

The ELITE Tool

Palantir developed the "Enhanced Leads Identification & Targeting for Enforcement" (ELITE) tool, which **allowed ICE** to populate maps with deportation targets and assign "address confidence scores" to guide raids.

The £330m Contract


Palantir's controversial 2023-2025 takeover of the NHS "Federated Data Platform."

Mission Creep

Military-grade surveillance software now manages intimate medical histories, raising fears of a "vendor lock-in" where an opaque American corporation becomes the un-fireable gatekeeper of UK health infrastructure.

Resistance

Direct opposition from the **British Medical Authority** over the lack of transparency in how algorithms process patient "anonymity."





Discord, Reddit, Roblox, & The **Biometric Dragnet**

PERSONA: Age Verification or National Surveillance?

The Partnership

Discord, Roblox, OpenAI mandate for "selfie" age verification via Persona.

Discord stated in Feb 2026 that all data would stay on-device, which would not be true if Persona is the provider.

The Link

Persona is heavily bankrolled by Peter Thiel's **Founders Fund** (leading \$200m+ rounds). Critics argue this creates a "circular surveillance" model where one billionaire's investment group (Thiel) funds the identity layer used by the platforms that his other company (Palantir) monitors.

The Risks

Concerns that these "age checks" are feeding a global, Palantir-linked biometric database that bypasses traditional privacy laws.

Despite claims that data is "deleted," civil liberties groups (like the EFF) warn that Persona retains **biometric embeddings**—machine-readable maps—which can be cross-referenced indefinitely across different apps.



The Gilded Web – The **2026 Epstein Files**

Jeffrey Epstein: The Strategic Financial Partner



Valar Ventures

2026 DOJ files confirm Epstein was a **Limited Partner** in Thiel's fund Valar Ventures (2014–2019).



Taxation Synergy

Epstein reportedly provided the taxation maneuvers that allowed Thiel to build a **\$5 billion tax-free Roth IRA**.



The Shadow Board

Epstein acted as a critical bridge between Silicon Valley elite and global intelligence circles. Emails from former Israeli PM **Ehud Barak** describe Epstein and Thiel as "owners" of joint cyber ventures.

From Westminster to the White House



The Mandelson Scandal

Lord Peter Mandelson's firm lobbied for Palantir's NHS deals while he maintained a "reputation rebuilding" friendship with Jeffrey Epstein.

JD Vance's political career was **bankrolled by Thiel**, creating a direct ideological pipeline from Palantir's headquarters to the executive branch.

The Global Pushback

The GP Revolt (2025-2026)

The Privacy Hardware Boom
